#### **Town Manager's Report**

Budget season is moving into its next phase. The Board of Education's Budget has been provided to the Town Council and I will soon be delivering my proposed budget for 2024-2025. Presentations of both the proposed Board of Education Budget and proposed Town Budget will be made on April 15<sup>th</sup> at 7 p.m. in the Town Council Chambers followed by the Budget Public Hearing. This will be followed by a series of Budget Workshops, to be held by the Town Council before the final budget adoption vote by May 15<sup>th</sup>. In order to ensure a more transparent process and to provide better access to citizens during this process, all budget workshops will be held in the Town Council Chambers and live-streamed. Residents will then have access to the recordings from our website. Please take advantage of this opportunity to engage in this important process.

At the Town Council meeting on March 18<sup>th</sup>, the Council approved the reallocation of funds to design and develop a new multi-use, synthetic turf field at Mill Woods Park. Staff will be moving forward to hire a consultant to develop a design for the new field and to update the Mill Woods Park Master Plan. This work will include a public engagement piece, as I know residents in the area want their voices heard as the project moves forward.

If you haven't ordered your brown yard waste barrel yet; the collection program starts next week. The Town of Wethersfield now offers a yard waste collection program. Separating yard waste from the green trash barrels greatly

reduces the volume of trash sent to regional trash facilities and reduces the amount of methane gas released into the atmosphere. It's a great way for Wethersfield residents to contribute to Wethersfield's environmental sustainability efforts. The program runs the first full week of April (April 1st this year) through the last full week of November. The program will not replace the fall leaf collection program. Residents may purchase a 95-gallon brown barrel for yard waste. The brown barrel cost is \$98.64. Call Paine's Inc. at (860) 844-3000 to order a brown barrel. Payment with a credit card or check prior to barrel delivery is required. This is a one-time fee and the resident then owns the barrel and is able to take with them should they move. Initial limit of 1 barrel per household. Alternatively, residents can utilize the 30-gal compostable lawn and leaf bags that they can purchase from any hardware or home improvement store. Yard waste collection will be on the same day as your current recycling pick up (every other week). A reminder that yard waste is not allowed in the green, blue or pink bins and this will be strictly enforced moving forward. Do your part to help us reduce our environmental impact!

#### **ENGINEERING**

- Revised Engineering Permit Fees: Permit fees for contractors working within the public righty-of-way will increase from \$40 to \$60 each starting Monday April 1<sup>st</sup>. New permit forms and associated information is available at <a href="http://wethersfieldct.gov/engineering">http://wethersfieldct.gov/engineering</a>.
- DOT Putnam Bridge Rehabilitation (State Project No. 0053-0199): DOT will be holding a virtual public meeting for
  the Towns of Wethersfield and Glastonbury on <u>Thursday April 4, 2024 at 7:00 p.m.</u> to discuss an upcoming bridge
  rehabilitation project. The work will address water leaks through the concrete bridge deck and associated corrosion of
  the steel substructure with construction expected to occur in 2026-2027. Residents may register to attend at

- Sidewalk Repairs: All property owners are reminded that per the Town Ordinance, owners of land fronting upon any street are responsible to replace, repair or otherwise correct defects in any sidewalk located within the public right-of-way adjacent to their property. Staff will be inspecting sidewalks along roads to be paved and other areas throughout Town. If you receive a notice to repair a sidewalk and have questions, or if you encounter any sidewalk safety concern, please contact the Engineering Department at 860-721-2850 or <a href="mailto:engineering@wethersfieldct.gov">engineering@wethersfieldct.gov</a>. The Town has a Residential Sidewalk Assistance Program to complete sidewalk repairs and replacements within the right-of-way to eliminate safety hazards that is available to residential property owners who have a demonstrated financial need for assistance. Funds are available on a first-come, first-serve basis until expended. Please contact the Engineering Department or the Social and Youth Services Department at 860-721-2880 for additional information.
- Temporary Great Meadow Rd Trail: The state has informed the Town that at this time, they plan to open the Putnam Bridge Trail in mid-May. Staff has developed plans to provide a temporary, designated trail in Great Meadow Rd between the bridge and Hart St until such time the permanent trail can be constructed. Some of this work was delayed; however, Paramount Construction is currently scheduled to install a temporary pavement overlay in limited areas along the road within the next two weeks, which will be followed by revised line striping, new signage and placement of vertical delineators.
- MDC Water Main Improvement Projects: MDC plans to complete water main improvements along Northbrick Ln, in the Goodrich Dr neighborhood and along Silas Deane Hwy to the south of Mill St starting in 2024 with construction completed in 2025.
- CNG Gas Main Improvements Projects: CNG plans to replace gas mains within neighborhoods near Stillwold Rd, Cumberland Rd and Edward St in 2024.
- Spring Paving Program: Town crews have started replacing catch basin tops and sidewalk ramps, and at this time, we anticipate that General Paving will start paving preparations in early-May with Tilcon commencing with milling and paving operations in mid-May.
